REFUND POLICY

Parents of Candidates, who are selected to pay the admission fees of their wards, be informed about the refund policy of fees in case of withdrawal from our school

Withdrawal before 31st March 2027 - Students applying for refund of fees on or before 31st March 2027 for the next session are to be refunded full fees paid except the Admission Fee of Rs. 100000.

Withdrawal from 1st April 2027 onwards - Students applying for refund of fees on or after 1st April 2027 for the next session, Prorata fees except Admission fee is to be refunded.
